### *Explanation and Terms of Gift Membership*

- ◆ A GIFT Membership is defined as a membership with all rights and privileges with the exception of voting or holding office and is for the term of one year.
- ◆ Any full member in good standing can give a gift membership.
- ◆ Gift memberships must be approved by vote in the established process for all memberships.
- ◆ The giftee must own an Anatolian and if there are reservations for a giftee, that giftee may not convert to full membership until such time as the stated issues are resolved.
- ◆ Conversion to Full membership can only happen if the member submits a completed and signed application and the Gift membership was approved with no reservations.
- ◆ Upon approval for Full membership, the time requirement toward COE standing shall be retroactive to the beginning of the Gift membership, if approved with no reservations.

*Initial applications/dues received after October 1st of the year will be good throughout the following year. Otherwise, dues are due January 1st.*
